"Nov 2" results report:

- This is run from the  
first copy of the memory card, #215A00  
- According to the memory card status  
report, a total of three memory cards  
were made

- A second memory card was used  
for the Nov. 15 report, #215A01

- No explanation of where memory card  
#215A02 went.

- According to Thomas James,  
Leon County Information Systems  
Officer, the system will only accept  
the last memory card run. For  
example, if you have 3 cards,  
#00, 01, 02, GEMS will only  
accept the last, #02. That's according to  
TJ of Leon County, where the same  
system was used. We have not  
tested whether GEMS will accept  
earlier versions of the card,  
however.

- Regardless, what we have here  
is multiple versions of a card with  
one unaccounted for, with  
results that don't match.

- The results on the Nov. 2 upload  
show 880 votes with 520 for Bush,  
351 for Kerry, and 6 for Nader,  
for 877 votes total.

This implies 3 undervotes.

- The next anomaly is that we  
received two identical copies of the  
Nov. 2 report. One was affixed to  
the zero report for precinct  
#108 (but with signatures  
for #215 on that zero  
rept.) The other was  
affixed to the zero report for #215.

"Nov. 15" report:

- This was run from memory  
card #215A01

- It has fewer votes than Nov. 2 report

- The "memory card status report"  
has two uploads, one on  
Nov. 2 and one on Nov. 15.

The Nov. 2 upload has only 422  
votes, but the Nov. 2  
poll tape has 880 votes.
